If the intended use of an image is for publication, permission is authorized for the one time, non-exclusive use of the image. Any change in use from that stated on this application, or subsequent reuse of the work beyond that specified in this agreement requires the written permission of The Historical Society of Cheboygan County, Inc. Any subsequent use constitutes reuse and requires a new **Application for Permission to Publish** be submitted.

Permission to reproduce images is valid only for the individual, company, or institution that signs the agreement and may not be transferred, assigned, sold or otherwise disposed of without written permission of The Historical Society of Cheboygan County, Inc.
